MINUTES OF THE CALLED MEETING HELD

MONDAY, JULY 30, 2012 AT 4:30 P.M.

The White County Board of Commissioners held a Called Meeting on Monday, July 30, 2012 at 4:30 P.M. in the Grand Jury Room of the White County Courthouse. The purpose of the Called Meeting was to consider adopting a resolution setting the 2012 millage rate for the unincorporated area White County. Present at the meeting was: Chairman Travis Turner, Commissioner Terry Goodger, Commissioner Lyn Holcomb, Commissioner Edwin Nix, Commissioner Craig Bryant, County Manager Michael Melton, Finance Director Vicki Mays, and County Clerk Shanda Smallwood.

Chairman Turner called the meeting to order.

Ms. Vicki Mays made the 2012 millage rate presentation (see attached presentation).

Upon a motion made by Commissioner Goodger, seconded by Commissioner Nix there was a unanimous vote to adopt the following resolution (County Resolution No. 2012-16) setting the 2012 millage rate for White County (County, State, School, and School Bond) thereby providing authorization for the Chairman to execute:

- PT 32.1 Form, Computation of millage rate rollback and percentage increase in property taxes – 2012;
- PT 35 Form, County millage rate certification for tax year 2012;
- Certification of insurance premium tax being used for fire protection / emergency services in the unincorporated area of White County; and
- Certification of pending appeals.

RESOLUTION NO. 2012-16

A RESOLUTION SETTING THE YEAR 2012 MILLAGE RATE

WHEREAS, the White County Board of Commissioners is the taxing Authority of White County; and

WHEREAS, the digest for the taxable year 2012 has been established; and

WHEREAS, the White County Board of Commissioners has adopted a budget for the fiscal year beginning July 1, 2012, wherein there is included a portion of revenues to be derived from property taxes; and

WHEREAS, the White County Board of Education has approved an M&O millage rate for the taxable year 2012, along with a school bond millage rate;
