## MINUTES OF THE REGULAR MEETING

# HELD MONDAY, JANUARY 13, 2014 AT 4:30 P.M.

The White County Board of Commissioners held a Regular Meeting on Monday, January 13, 2014 at 4:30 p.m. in the Board Room at the White County Administrative Building. Present at the meeting were: Chairman Travis Turner, Commissioner Terry Goodger, Commissioner Lyn Holcomb, Commissioner Edwin Nix, Commissioner Craig Bryant, County Manager Michael Melton, Finance Director Vicki Mays, and County Clerk Shanda Murphy.

Chairman Turner called the meeting to order.

Following the Pledge of Allegiance, Ms. Teresa Leahey provided the invocation on behalf of the White County Ministerial Alliance.

Upon a motion made by Commissioner Bryant, seconded by Commissioner Holcomb there was a unanimous vote to adopt the minutes of the November 25, 2013 Called Meeting (including sealed Executive Session Minutes) and the minutes of the December 17, 2013 Called Meeting(including sealed Executive Session Minutes).

Chairman Turner announced a change to the agenda. He stated that the Board of Commissioners would consider entering into Executive Session in order to discuss litigation at the end of the meeting.

A proclamation was presented to Ms. Betty Highsmith in recognition of her dedication and contributions to White County.

On behalf of the City of Cleveland, Mayor Don Stanley and Councilman Ed Young presented a check in the amount of \$144,406.00 to the Board of Commissioners for the City of Cleveland's contribution to the Event Park Project. Mayor Stanley stated that the City was in full support of the project.

Mr. Clay Pilgrim, with Rushton & Company, presented the Fiscal Year 2013 Audit Report for White County (see attached report). In summary, Mr. Pilgrim state the County has received a clean / unmodified audit opinion and the county ended FY 2013 with an unassigned fund balance of \$6,110,305.00 (5.5 months).

Chairman Turner opened the floor for any comments or questions regarding the audit. There were no questions or comments.

Chief Brian Kelley with the City of Gainesville Police Department presented Sheriff Neal Walden and the White County Sheriff's Office with State Certification on behalf of the State of Georgia Law Enforcement Certification Program, highlighting the significance and benefits of

this achievement. Chief Kelley noted that the White County Sheriff's Office was one of the only 21 Sheriff's Offices in the State of Georgia to receive this certification, out of 159 counties, and was among the total 109 certified law enforcement organizations, out of 700 statewide. Deputy Robyn Still received special recognition as the White County Sheriff's Office State Certification Coordinator and Sheriff Neal Walden also recognized the entire command staff for their dedication to achieving the State Certification.

Chairman Turner recognized the White County Chamber of Commerce Adult Leadership Program Participants and thanked them for their community involvement.

Upon a motion made by Commissioner Holcomb, seconded by Commissioner Goodger there was a unanimous vote to approve the Byrne Memorial Justice Assistance Grant award through the Criminal Justice Coordinating Council for the Appalachian Drug Task Force for grant period January 1, 2014 - December 31, 2014 in the amount of \$144,171.00.

Upon a motion made by Commissioner Bryant, seconded by Commissioner Nix there was a unanimous vote to adopt the following resolution (County Resolution No. 2014-01) setting the qualifying fees for the County Offices to be filled in the upcoming 2014 Primary or Election:

## **RESOLUTION NO. 2014-01**

**WHEREAS,** the White County Board of Commissioners, as the governing authority of White County, is required by the Official Code of Georgia Annotated Section 21-2-131, to fix and publish a qualifying fee for each county office to be filled in the upcoming primary or election;

**AND WHEREAS,** the White County Board of Commissioners is required, no later than February 1 of 2014 to fix and publish such fees;

- 4) Board of Education, District 4 as currently held by Mr. Barry Vandiver \$27.00

The County Manager is hereby authorized to execute any title transfers and bills of sale to the successful bidders on the personal property.

Chairman Turner noted, regarding funding from Legacy Link, Inc. to White County for the funding of transportation and food services at the Senior Center that Legacy Link routinely sends addendums to the Fiscal Year contract throughout the contract year and in the case of FY 2014 funding had decrease significantly.

Ms. Bonnie York, Director of Senior Services, stated that all in total the budget was in deficient \$25,361.00. She explained that this amount would satisfy the budget need for the remainder of the fiscal year at the current funding levels and would allow her to service all individuals currently on the waiting list (28 home delivered meals and 7 congregate meals).

Upon a motion made by Commissioner Nix, seconded by Commissioner Holcomb there was a unanimous vote to approve additional funding for the White County Senior Center in the amount of \$25,361.00 – to be funded from contingency.

Upon a motion made by Commissioner Holcomb, seconded by Commissioner Nix there was a unanimous vote to approve addendum #2 of the contract with Legacy Link for the funding of nutrition and transportation services at the White County Senior Center.

Chairman Turner stated that in the future, a waiting list for participation at the Senior Center should not be started until the Board of Commissioners is advised.

Upon a motion made by Commissioner Goodger, seconded by Commissioner Bryant there was a unanimous vote to table the discussion regarding the naming of the Event Park until the January 27, 2014 meeting.

Mr. Kevin Hamby, CHA SPLOST Manager, presented the monthly SPLOST Status Report (see attached).

Ms. Vicki Mays, Finance Director, presented the monthly Financial Status Report (see attached).

Mr. Michael Melton, County Manager acknowledged Garland & Judy Lovell's letter regarding the exceptional service provided by White County Public Safety and Emergency Medical Services. He also acknowledged Public Safety Director, Mr. David Murphy's, achievement in the completion of the Advanced Emergency Management program. Mr. Melton presented the proposed change for the Tesnatee Precinct voting site change from the White County YMCA Parks & Recreation Facility to Mt. Yonah Baptist Church, on behalf of Mr. Garrison Baker, Elections Superintendent.

Chairman Turner asked that Mr. Melton instruct the YMCA Staff to post signs during the first election cycle advising the voting location had moved to Mt Yonah Baptist Church.

Commissioner Goodger asked that Commissioner Nix contact Mr. Yancey, owner of the vacant parking lot adjacent to the Courthouse, to try to arrange a temporary parking area to be utilized during the Event Park construction.

Commissioner Bryant stated that the Planning Commission needed to relocate their meetings from the Courthouse in order to save on the overtime required for the Sheriff's Office to provide security personnel.

Chairman Turner opened the floor for citizen participation.

There was brief discussion regarding the new meeting location.

Upon a motion made by Commissioner Goodger, seconded by Commissioner Holcomb there was a unanimous vote to enter into Executive Session in order to discuss potential litigation.
