

**WHITE COUNTY BOARD OF COMMISSIONERS**

**MINUTES OF THE CALLED MEETING HELD**

**WEDNESDAY, APRIL 15, 2015 at 8:00 A.M.**

The White County Board of Commissioners held a Called Meeting on Wednesday, April 15, 2015 at 8:00 a.m. in the Board Room at the White County Administration Building. Present at the meeting were: Chairman Travis Turner, Commissioner Terry Goodger, Commissioner Lyn Holcomb, Commissioner Edwin Nix, Commissioner Craig Bryant, County Manager Michael Melton, County Attorney Bill House, Director of Public Works Terry Palmer, and County Clerk Shanda Murphy. The purpose of the Called Meeting was to consider entering into Executive Session in order to discuss potential litigation and personnel.

Chairman Turner called the meeting to order.

Upon a motion made by Commissioner Holcomb, seconded by Commissioner Bryant there was a unanimous vote to enter into Executive Session at 8:03 a.m. in order to discuss potential litigation and personnel.

Upon a motion made by Commissioner Nix, seconded by Commissioner Bryant there was a unanimous vote to exit Executive Session.

Upon a motion made by Commissioner Nix, seconded by Commissioner Goodger there was a unanimous vote to approve up to \$20,000.00 in SPLOST funding for the installation of guardrails by Martin-Robbins Fence Company, Inc. along the bridge at Gene Nix Road.

There was also a consensus that the White County Road Department would pick up jersey barriers from Lumpkin County within the day and have these installed along the bridge until the guardrails could be installed within the next two (2) weeks.

Mr. Terry Palmer, Director of Public Works, stated that his staff would pick up the barriers and have the barriers installed within the day and work with Martin-Robbins Fence Company, Inc. to have the guardrails installed as soon as possible.

Upon a motion made by Commissioner Nix, seconded by Commissioner Holcomb there was a unanimous vote to adjourn the meeting.
